

Eichmann's cronies must be punished

Adolf Eichmann SS murderer of six million Jews has been sentenced to death.

After nearly twelve months, the trial is over, with Eichmann found guilty on all major counts.

HE is appealing to the Israeli Supreme Court against the verdict.

And while Eichmann waits in an Israeli jail the result of this appeal, many of those who helped him in his grisly deeds are living comfortably in West Germany, drawing generous pensions for their "service to the Fatherland."

Dr. Globke for example. Under Hitler he headed a department in the Ministry of the Interior which dealt with the Jewish question. In this post he wrote the "racial laws" which provided the "legal grounds" for depriving the Jews in Germany of their citizenship and their human rights and destroying them in death camps.

Eichmann did the killing. Globke provided the legal grounds for it. ~~Eichmann has been con-~~
demned to death; Globke is State Secretary in the Adenauer Government in Bonn and one of the Chancellor's closest associates.

Strange silence

Strange feature of the Eichmann trial was that although Eichmann's only defence was that he was "obeying orders" no mention of Globke's name was made.

Nor were any of the other Eichmann accomplices now living com-

...not were any of the other Eichmann accomplices now living comfortably in West Germany named.

There are, for example, some 500 doctors directly involved in exterminating prisoners and performing experiments on human beings in death camps.

Some of them have since become university professors and are now teaching the youth of Germany.

But the Israeli Government forbade any probing in this direction in the Eichmann trial because, in the words of Director General Jahlil in May, 1961: "Israel is interested in the development of relations with the German Federal Republic."

It is trying to raise a loan of 500 million dollars from the West German monopolists; and to help negotiations, Israeli Premier Ben Gurion sent a personal message to Adenauer through Eichmann's defence lawyer Servatius, assuring him that the "prestige" of West Germany would not be injured in the course of the trial.

Zionist fears

Professor Trevor-Roper of Oxford University remarked earlier this year that if the details of the Nazi-Zionist co-operation during the war had been disclosed the Eichmann trial might well have become the Ben Gurion trial.

So Tel Aviv and Bonn had a mutual interest in hiding the truth.

Washington also had advised the Israeli Government against "whip-

Israel Government against "whip-

ping up" public opinion against Bonn. Some influential circles there argued that NATO needed consideration before the six million people slain by Eichmann, Globke and their accomplices.

Eichmann deserves his death sentence.

He was accused not only by the six million dead but also by the three billion living.

Fascism threatened all mankind.

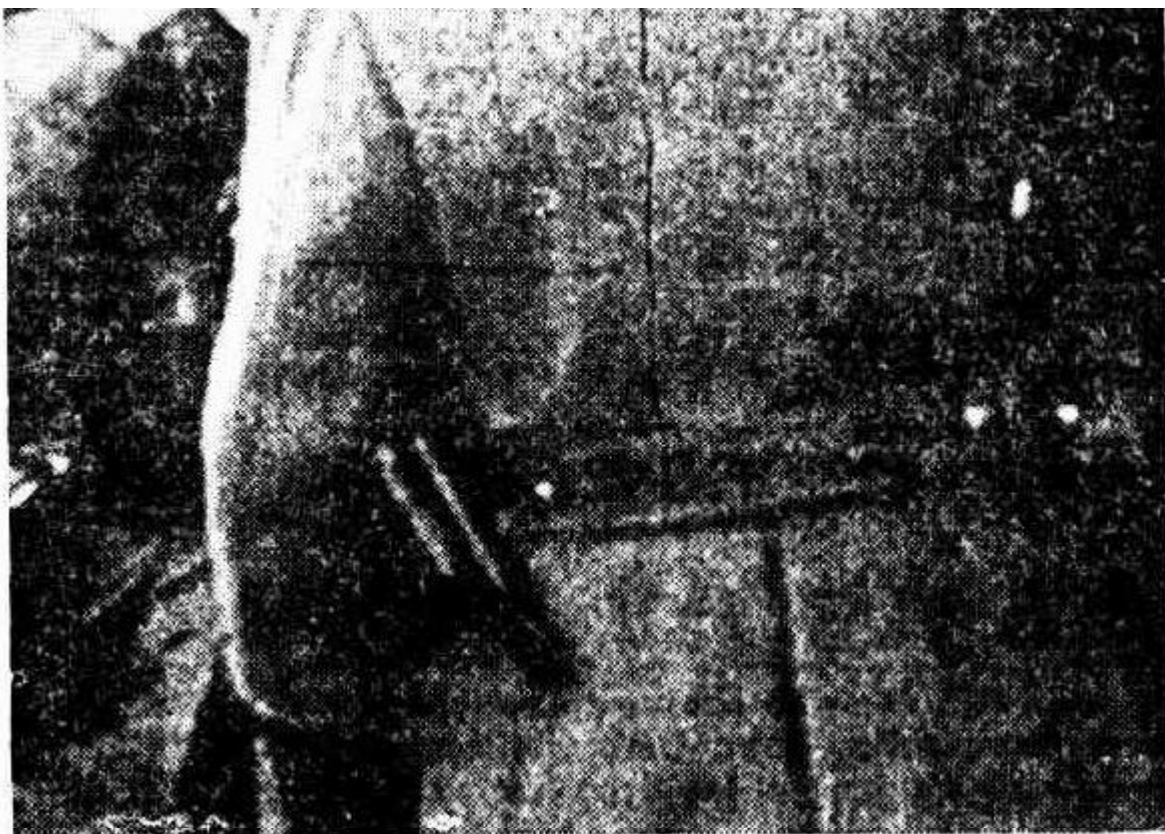
And the regrowth of German militarism, handmaiden of the Ger-

man monopolists who financed Hitler again threatens all humanity.

The three billion living will waste no tears on Eichmann; but for them the trial has not ended. It cannot be ended until the Krupps, I. G. Farbens and the other owners of West Germany, as well as the Globkes, Heusingers, Schroeders and the rest of their criminal tools are also brought to book.

These potential Eichmanns are now more dangerous to the world than the monster in human shape in an Israel jail.
